Ist of January, April, July, and October - Lead/Copper reminders for that quarter or compliance period

15th of every month - Bacteria reminders for monthly samples

15th of February, May, August and November - **Chemical** requirements for that quarter will be included with the monthly bacteria information

Second Reminder emails will be automatically generated and sent on the following dates:

22nd of March, June, September and December - Last call for chemical and Lead/Copper samples to be collected and results submitted








Click on One Stop data




Type in your public water system number and click enter
