Selectmen is exploring the advantages and disadvantages of adjusting our current work force to establish a single position as administrative safety officer responsible for fire, police, and safety personnel.

On October 22, Rye Selectmen Jenness and Moynahan met Peter Britz, Portsmouth Environmental Planner, and an intern from his office for the purpose of complying with RSA 51:2 "which provides that the lines between towns in the state shall be perambulated and the marks and bounds renewed once every seven years forever by the selectmen or by such persons as they shall in writing appoint for that purpose." Rye/Portsmouth marks and bounds were located beginning with a granite post marked "GPR" (the meeting point of Greenland, Portsmouth, and Rye, located in 1929 as 7 rods and in 1977 as 1,524 paces north along the railroad track from Breakfast Hill Road) and ending with an iron ring in a boulder on the edge of Sagamore Creek off Harbor View

which they are registered. declared voters (aka Independents) can request a ballot for either the Republican or the Democratic party. Once the undeclared voter has received that ballot and voted, however, he or she is considered to be a member of that party. To regain undeclared status, the voter may immediately go to the Supervisors of the Checklist, who are seated just outside the polling area, and fill out a brief form. The last opportunity to change party affiliation prior to the Primary Election was October 31, 2003.

Dog owners: When the first of the year rolls around it will be time once again to license your dog. You should take care of that chore anytime between January 1 and April 30 of each year. Simply bring in a copy of your dog's rabies certificate.

Drive. The language of the 2003 perambulation will replace "rods" and "paces" with highly accurate GPS (Global Positioning System) designations.

It is our intention to contact the selectmen of Greenland and North Hampton to complete the perambulation process along our remaining perimeter.

The long-awaited reconfiguration of Foyes Corner intersection by the State of New Hampshire Dept. of Transportation has been withdrawn at this time by Governor Benson. Over the past ten years traffic concerns have been voiced, the need for remediation established, four plans designed with one selected and approved, and fourteen affected properties have been notified and prepared for the change. About a year ago, we requested that the culvert under Sagamore Road on the easterly approach to the intersection be enlarged from 24" to 36" to avoid repetition of the spring flooding and road closure we have experienced in the past. This request had been integrated into the DOT plan. A letter has been sent to the Governor requesting reconsideration of his decision.

Rve continues as a member of The Coalition Communities, now 34 strong. As a House-Senate study committee attempts to fine-tune the new education funding bill, they have heard from some speakers seeking a return to the "donor town" situation. The Coalition is renewing its campaign "to persuade the Legislature to adopt a commonsense approach similar to other states that truly target aid to needy students." Coalition Communities believe this can be done successfully without a statewide property tax. Among the Coalition Communities, Portsmouth has shouldered the greatest financial burden, in excess of \$20.00 per capita. To date Rye has contributed \$32,000, which represents \$6.27 per capita. To carry on


the fight to rid the state of the donor town concept and pursue a targeted aid approach, we believe continued financial support of the Coalition is necessary.

Time to Prepare

On a recent site walk, the Selectmen, accompanied by Bud Jordan, Director of Public Works, visited more than a half-dozen areas where snow removal was or could become a problem if this winter replicates last year. Please be reminded that residents cannot place obstacles (rocks, shrubs, pipes, fences, planters, sprinklers, etc.) in the Town Right of Wav.

Last winter's snow volume resulted in damage to or destruction of a number of mail boxes. In order to provide your mail box with its best chance for survival, IT (THE MAIL-BOX, NOT THE POST) MUST BE PLACED THREE FEET FROM THE EDGE OF THE HIGHWAY. Town will not accept responsibility unless mailboxes are installed at the proper distance from the plowed surface.

Planning Board Activities Explained

NEW TECHNICAL REVIEW COMMITTEE (TRC) MEETING FORMAT

A change to the Technical Review meeting, proposed by board member Bob Hablutzel, was put into effect at the November meeting. The TRC was originally set up to check applications for completeness before they entered the formal approval process. The technical meetings will still fulfill this role but a new second part of each meeting will be devoted to long-range planning on topics such as zoning changes, Master Plan revisions, and compliance with regulations.

LONG-RANGE PLAN

Our first focus with this new TRC approach is the Master Plan because all other changes flow from it. There are several areas in the Master Plan that currently need updating. The updating is being led by member Kim Reed with alternate Gary Dodds. The first area being reviewed is the proposal from the Citizens' Committee on Land Use chaired by Bill Veazey. As has been previously reported, they have come up with proposals for sidewalks, realignment of streets in Rye center, open space zoning, and revisions to make better use of the town common areas.

Major changes in the Master Plan

that will be considered are modifications to address the unique characteristics of the different areas of our town. The Master Plan needs to recognize the essential differences in three major areas: (1) the "built-out" area along the coast; (2) the area along Lafayette Road that has potential for commercial development and open space residential development; and (3) the major inland parts of Rye where maintenance of a "semi-rural" environment is the major factor. The very different needs of these areas are not currently addressed by the Master Plan and the Zoning Ordinance.

PAST AND PRESENT AS PROLOGUE TO THE FUTURE

The experience the board has gained during the past years in administering the Land Development Regulations is, of course, the prime input to any long-range planning. So far in 2003 the Planning Board has ruled on many kinds of applications:

12 New Home Sites

- 2 Lot Line Adjustments
- 1 Minor Subdivision
- 1 Condo conversion
- 3 Major Site Developments
- 2 Minor Site Developments

A new experience this year that expanded our viewpoint, however, was the Capital Improvements

Program (CIP) Committee led by Priscilla Jenness for the Selectmen and Bob Brown for the Planning Board. The CIP (analogous to the Capital Budget that a city such as Portsmouth has) collects and displays Rye's six-year plan for all kinds of items and projects costing \$10,000 or more. All items that the town departments and the School District are planning are required to be listed and explained in this program. Current examples are the new public safety building, recycling center improved facilities, and replacements for Highway, Fire, and Police equipment. The CIP committee's view was expanded by the contributions of Joan Sweeney, an independent consultant in Rye, who contributed her time pro bono. You can review the CIP report on the town website for a look into Rye's future.

INVITATION

Regular Planning Board meetings are on the second Tuesday of the month. The TRC meets on the Tuesday two weeks before the regular Planning Board meeting. As with all our meetings, notice is posted on the web site and town bulletin boards. We hope you will take time to drop in and give us your input.

Please Do Not Be Cold This Winter

Rockingham Community Action (RCA) is taking applications for their fuel assistance program. Households who are responsible for paying heating bills, have yearly heating costs of at least \$100.00, and meet the household income levels are eligible.

Please call the agency at 436-3896 or 1-800-639-3896. Fuel assistance brochures detailing the fuel assistance program are available at the Selectmen's office.

RCA will also take your application for the NH Electric

Assistance Program. Depending on your income, households may be eligible for a discount on their monthly electric bills. The Selectman's office has the brochure for the Electric Assistance Program.

Abatement Applications Are Available in the Assessing Office

By now, you have received your second issue 2003 tax bills, which means appeal season is upon us. If you would like to challenge your valuation, applications for abatement are available in the Assessor's Office at Town Hall. The deadline is March 1, 2004.

As a reminder, we assess property as it stands on April 1. Any structural changes that occurred after that date will be picked up next year. What you pay on the first issue acts as a credit or down payment to what your true tax is, which is determined with the annual tax rate generally set in October. Items you vote on at the Town Meeting this March will be funded/added into the fall tax rate next year thus having an effect on your tax bill. Stay part of your community! Have a say: V O T E!

As we have touched on in the past, Rye's valuations will be subject to annual reviews. Commencing in 2004, there will be a four-year cycle in which one-fourth of the structures in town will be inspected annually. The purpose is to verify or correct measurements and interior features for purposes of accuracy so that no taxpayer is erroneously assessed. With the State of NH's certification requirements, it is very important that we strive to keep our assessments as close to 100% as possible. Besides making valuation practices more uniform throughout New Hampshire, we are hoping to see fewer spikes or shockers to our assessment base, thus hopefully contributing to a more stable annual rate. As our base rises, the tax rate generally drops, providing spending is carefully monitored.

Police Department Now at Full Strength

The Police Department is happy to report that we are at full strength for the first time since last December. This was accomplished with the hiring in late August of Officer Blais, whom I introduced in the last newsletter, and the hiring of Officer B.T. Conlon in mid-September. Officer Conlon has three years of experience with the Rochester Police Department, with his last assignment being that of School Resource Officer. We were lucky to get Officer Conlon because he is already state certified and has the required minimal field training. Running shorthanded for the summer put a strain on all our officers because six officers were required to do the work of eight. I commend them for a job well done.

Our speed trailer grant has been completed and forwarded to the state. We hope to be hearing some good news shortly. Speaking of speed enforcement, please remember that winter driving conditions will be upon us shortly. Give yourself some extra time to clear windows and slow down as you drive. Stopping distances increase in the winter and visibility at intersections/driveway entrances is poor. As you clear your driveways of snow, please remember that shoveling snow into the road or plowing it across the road is against the law.

I would like to remind our senior citizens to give me a call if you would like an emergency cell phone to keep in your car. These can be particularly helpful during the winter months. As a final reminder, please be sure your house is clearly numbered so that emergency crews can see your address from the street. This can save precious time as we try to locate you or a neighbor in need of emergency services.

Seasonal Cautions Urged by Fire Chief

Winter is upon us again and with it the safety issues related to it. For your safety and the safety of your neighbors, clear your walkways of snow and ice. Adopt a hydrant near your house and keep it shoveled. Be sure your house number is visible and not obscured by snow. Review your house exit drill plan for any changes that winter may require. If you haven't changed your smoke detector batteries, do it now. Have all heating appliances checked for proper operation prior to heavy usage. Give yourself time to properly and completely clear your vehicle of snow and ice.

Christmas will be here too soon for many of us and it has its particular safety issues. Check all extension cords for condition, and use care when routing them to your tree, decorations, or other electrical equipment. Many Christmas decorations are stored in areas that may be visited by rodents, which may gnaw insulation. If you have a live tree, be sure to keep it well-watered and use only low-heat-producing lights.

The Public Safety Facility Committee has worked very hard to have revised plans and cost figures ready for review before the deliberative session in January. Hopefully it will meet with everyone's approval and become a reality next year. The Safety Facility Committee deserves a lot of praise for seeing this project through for the last several years.

I would like to thank everyone for their support of the Fire Department over the last year. There have been many personnel changes and additions during that time and many of you may not have met all the new faces. Please feel free to visit the station and introduce yourself; ask any questions you might have about safety or our general operations. May each and every one of you have a safe and happy holiday season.

Public Safety Facility Committee Reports on Ongoing Progress

Of the three Warrant Articles voted on in March that were directly related to this important town project, the residents voted strongly (1) in favor of purchasing the real property adjacent to the existing fire station, and (2) in favor of providing additional monies to continue with the design process and the production of Construction Documents, which will be required when the Town decides to build this facility.

The third Warrant Article, which would have permitted the raising of funds by bond and by gifts and grants to build the project, although receiving more than a simple majority approval, did not receive the required three-fifths super majority. Based on the voters' approval of the first two items, the Committee understood that the voters supported the creation of a combined public safety facility in a central location in the Rye Town Center, but were not prepared at that time to underwrite its estimated cost. Thus the most important parts of the process were allowed to proceed, and the Committee is doing just that.

The focus of the Committee continues to be to create a combined public safety facility that will serve the needs of all the citizens of Rye from an optimum geographic location in the Rye Town Center, with a building having an architectural presence befitting the character of Rye. The Selectmen consummated the terms of the Purchase and Sale Agreement on April 30, 2003, and the Town is now the owner of the property, known as the "Govoni House," located at 551 Washington Road.

Proceeding along the previously established timeline, the Rye Public Safety Facility Building Committee has worked with HKT Architects through further revisions to the Schematic Design documents. The Committee has been eager to find

additional means by which the required size, the massing, and the estimated cost could be further reduced. Further refinements of, and a reduction in, the required floor area have been accomplished by a further critical review of programmatic needs by the Fire and Police Chiefs. This effort has focused on reducing the area and apparent mass of the building by placing more of the net assignable space on the level below the first floor and on the second floor of the building, and to preserve developable space above the apparatus bays. With such changes, the massing and length of the building along the Washington Road streetscape have been significantly reduced.

The Schematic Design phase is now complete, and the design team is moving on to the Design Development phase, during which the details of the project, along with details of an estimated cost, will be developed. This will be followed by the Construction Documents phase, during which the details of construction, including drawings and specifications and bidding documents, will be created.

The Committee and HKT continue to meet with members of the Historic District Commission and all other interested townspeople to receive their further input. Further meetings will take place with all interested parties as the design evolves.

The Building Committee continues with its plans to save the Govoni House by considering all possible alternatives and focusing on a plan to integrate the house into the set of rental properties, now known as The Parsonage Apartments managed by the Housing Partnership, nearby on the streetscape of Washington Road in the Rye Town Center.
