SELECTMEN'S MESSAGE

"What's the Effect on My Taxes?" and Other Items Discussed

RIOR TO PREPARATION of the 2006 Operating Budget, department heads were requested to "hold the line" and your selectmen did likewise. Consequently, the budget was finalized at \$6,992,540, up \$421,826 over 2005 (\$6,570,714). This figure does not contain any of this year's Warrant Articles. It does reflect contractual obligations and higher fuel costs as well as a cost of living adjustment of 4.3%, up from 2.6% in 2005.

Public Safety Building Update

Our new Rye Public Safety Building is behind schedule. The good news is that it is within budget. We are assured that, upon completion, we will have a quality building suited to the purposes for which it was designed.

It is planned that both Fire and Police Departments will be operational from this new facility in June.

The Deliberative Session was held Saturday, February 4 and was poorly attended, perhaps due to lack of controversial topics. Discussion focused almost exclusively on petitioned articles.

ARTICLE 3 ZONING ORDINANCE AMENDMENT QUESTION

Amendment 1. Proposed by the Rye Planning Board

Are you in favor of the adoption of Amendment 1, as follows:

To add a new Section 202.4a to the Zoning Ordinance as follows: 202.4a Lots with two or more dwel-

ling units A lot which has two or more dwellings

is a nonconforming use. On such lots, the following are prohibited expansions of a nonconforming use. (See Section 602.1). · Increasing the building footprint of a

dwelling.

· Enlarging the bulk of a dwelling.

· Adding decks, porches or other appurtenances to a dwelling, including roof decks.

 Enlarging decks, porches or other appurtenances of a principal building.

A REMINDER

If you study the ballot at home and fill in the checklist on the back page of this issue, you'll save yourself lots of time in the voting booth on Tuesday! This provision applies to all lots which have two or more dwellings, including lots having such dwellings in the condominium form of ownership.

Add the following to Section 602.1

In the SR and GR Districts, a lot which has more than one dwelling is a nonconforming use, and expansions of such dwellings are prohibited. See Section 202.4a.

Amendment 2. Proposed by the Rye Planning Board

Are you in favor of the adoption of Amendment 2, as follows:

To amend Section 503 Condominium <u>Conversions</u> by changing the require-ments of 503.3 <u>Criteria for Special</u> Exceptions.

G. For condominium conversions involving detached dwellings, if the amount of land designated as common area is less than 1/3 [90%] of the area of the parcel [not designated for buildings and individual unit owners' vehicles], each limited common area assigned to a detached dwelling shall meet the minimum lot area and frontage requirements of this ordinance. (Note: Proposed new language is in brackets and in bold print. Deleted language is struck through.)

Amendment 3. Proposed by the Rye Planning Board

Are you in favor of the adoption of Amendment 3, as follows:

To amend the Zoning Ordinance by adding the following Section 401:

SECTION 401 RETIREMENT COMMU-NITY DEVELOPMENTS (RCD'S)

401.1 Authority. This section is adopted as an Innovative Land Use Control, pursuant to RSA 674:21.

401.2 <u>Purpose.</u> The purpose of this section is to provide flexibility of zoning regulations in order to encourage the construction of small residential neighborhoods spread throughout Rye which are designed and constructed to meet the unique needs of people 62 years of age and over, while ensuring compliance with local planning standards, land use policies, good building design, and the requirements for the health safety and general welfare of the inhabitants of Rye.

401.3 Special Use Permit Required. Retirement Community Developments (RCD's) require a Special Use Permit from the planning board. The planning board may approve a Special Use Permit for an RCD which complies with the requirements of this section and the requirements of the planning board's Land Development Regulations for major site developments. Applications for a Special Use Permit shall be submitted to the planning board and reviewed in accordance with the planning board's procedural requirements for major site developments. The planning board may amend its Land Development Regulations to include special requirements for the review and approval of RCD's.

401.4 Requirements for RCD's.

A. Location. An RCD may be located in any zoning district in Rye, except within the Rye Beach Precinct. An RCD shall not

be located within 1/2 mile of another RCD, as measured between boundaries of the RCD parcels, along existing street lines.

B. <u>Parcel Size</u>. The minimum parcel size for an RCD shall be 10 acres, which may include wetlands.

C. <u>Frontage</u>. An RCD shall have a minimum contiguous frontage on a town road or street of 150 feet. Each dwelling within an RCD shall face upon either an existing town road or street or on a private way constructed within the RCD.

D. <u>Number of Dwelling Units.</u> An RCD shall have a minimum of eight (8) dwelling units, but not more than sixteen (16) dwelling units.

E. <u>Density</u>. The density of an RCD shall not be greater than four (4) dwelling units per contiguous upland acre. No single contiguous area of uplands on a parcel shall have a density greater than four (4) dwelling units per acres. The density is the maximum allowed, and it may be reduced by the planning board if the characteristics of the site; or the configuration of the site plan; or the relationship of the RCD to its environs so warrant.

F. <u>Bonus for Affordable Housing</u>. At its discretion, the planning board may approve a maximum number of dwelling units up to twenty-two (22) and a density not to exceed eight (8) dwelling units per contiguous uplands acre, provided that at least 15% of the total dwelling units are affordable housing units. To be considered as an affordable housing unit, a dwelling shall meet the following requirements.

1. Occupancy by a person(s) who would meet the income and asset limitations established by the Town for the elderly property tax exemption program.

2. If owned, the principal, interest, taxes and condominium association fees shall not be more than 40% of the income of the occupants.

The planning board may enact such regulations as are necessary to administer the affordable housing bonus provision and the continuing compliance with it.

G. <u>Types of Dwellings</u>. Dwelling types shall be of an architectural type and style deemed by the planning board to be compatible with the neighborhood and may include single family detached dwellings, duplexes and multi-family dwellings. There shall be no more than four (4) dwelling units in a single building. An RCD may have more than one type of dwelling. Site development review (i.e. site plan review) shall be required for all RCD's including RCD's composed of single and two family dwellings.

H. <u>Homeowner's Association</u>. All RCD's shall have a Homeowner's Association. The Condominium Declaration and By-Laws shall be approved by the planning board in accordance with the planning board's Land Development Regulations.

I. Bonus for Excellence in Design. The planning board may award a bonus of one or two dwelling units, total, beyond the 16 dwelling units allowed by Section 401.4 D., for excellence in design. In awarding the bonus the planning board may consider factors including but not limited to preservation of rural character, provisions for walking trails from the site to community facilities, innovative use of open space; and architecture. The planning board may enact amendments to its Land Development Regulations relative to the process and criteria by which the bonus may be awarded.

J. Building Spacing/Setbacks.

1. <u>Building Spacing</u>. All buildings in an RCD, including parking structures and accessory buildings, shall be separated by at least 25 feet.

2. <u>Setbacks</u>. No principal or accessory building or structure shall be located closer than 75 feet to a property line or street line. However, the planning board may reduce this requirement to 50 ft. upon a determination that the scale and location of a building will not be incompatible with or detrimental to the use and enjoyment of the adjacent parcel.

K. <u>Buffer.</u> The perimeter of all RCD's shall be a landscaped buffer zone at least 25 feet in width, which may consist in whole or in part of existing natural tree growth.

L. <u>Occupancy.</u> The occupancy of an RCD shall be restricted solely to persons age 62 or older, with no exceptions.

M. <u>Bedroom/Floor Space</u>. There shall be no more than two (2) bedrooms per dwelling unit. The minimum square footage of living space per unit shall be 800 sq. ft. and the maximum square footage of living space per unit shall be 1800 sq. ft.

N. <u>Parking.</u> Each dwelling unit shall be provided with a one car garage attached or in close proximity to the unit and one other parking space. Additionally, a plan for an RCD shall include adequate parking for visitors, as determined by the planning board.

O. <u>Town Wide Limitations.</u> RCD's are exempt from the Growth Management limitations of Article IX. A Special Use Permit shall not be approved for any RCD which would result in the total number of dwelling units in RCD's in the Town of Rye exceeding 2% of the total year round dwelling units in town, exclusive of units located within an RCD. (<u>Explanatory</u> <u>Note:</u> As of December 31, 2005, this would allow 51 RCD units in the town).

401.5 <u>Determinations Required for</u> <u>Special Use Permit Approval</u>. Prior to approving a Special Use Permit for an RCD, the planning board shall determine, by a vote on the record, that the RCD meets each of the following standards.

1. All requirements of Section 401.4 have been met. (This may be a single vote on the record).

2. The granting of the Special Use Permit will not be detrimental to adjacent property or the neighborhood.

3.The granting of the Special Use Permit will not be detrimental to the public safety, health or welfare.

4. The granting of the Special Use Permit will not be contrary to the public interest.

5. Unless otherwise prohibited by State or Federal law, the applicant will make reasonable provisions to assure that residents of Rye will have an opportunity to reside in the RCD.

401.6. Conditions. In approving a Special Use Permit, the planning board may attach such conditions to its approval as it deems necessary to further the objectives of this section, the zoning ordinance and the public health, safety

and general welfare.

401.7 Variances. Approval of an RCD is a privilege, not a right. The requirements of Section 401.4, A, D, E and O, which regulate the location, size, and density of RCD's and of Section 401.4, O, which regulate the total number of RCD units in town are fundamental to the intent of this innovative zoning provision. Any variance from the provisions thereof is hereby deemed to be inconsistent with the spirit and intent of the zoning ordinance and contrary to the public interest.

401.8 <u>Waivers.</u> An applicant may apply for waivers to the requirements of Section 401.4 C, E, J or K provided such waiver does not deviate from the requirement by more than 20% and provided that 2/3 of the planning board members present and voting determine that:

1. A unique and identifiable specific circumstance of the land warrants the granting of a waiver.

2. The granting of the waiver will not be detrimental to adjacent property or the neighborhood.

3. The granting of the Special Use Permit will not be detrimental to the public safety, health or welfare.

4. The granting of the Special Use Permit will not be contrary to the public interest.

401.9 <u>Fees</u>. The planning board shall charge an application fee for a Special Use Permit for an RCD, in addition to its fee for site plan approval and any fees for investigation and review allowed by RSA 676:4, I.(g).

401.10 <u>Conflicts.</u> Where the provisions of this section conflict directly with a requirement of the zoning ordinance or a requirement of the planning board's Land Development Regulations, the provisions of this section shall govern. Otherwise, all other requirements of the zoning ordinance and the planning board's Land Development Regulation shall apply to an RCD.

401.11 *Appeal*. Pursuant to RSA 676:5, Ill., appeals of any planning board decisions made pursuant to this section shall be taken to the superior court, not to the board of adjustment.

401.12 Webster at Rye. Webster at Rye is not an RCD. None of the provisions of this section apply to Webster at Rye.

Amendment 4. (By Petition) Are you in favor of the adoption of Amendment 4, as follows:

To amend Section 203.1 as follows:

Section 203.1 of the Zoning Ordinance (Permitted Uses in the Single Residence District – SR), paragraph H, (pertaining to Golf Courses that was added in 1999) be removed and that paragraph I be re-designated as H.

ARTICLE 4

Are you in favor of the adoption of Article 4, as follows:

To see if the Town will vote in accordance with RSA 31:95-d, IV(a) and (b) to rescind the provisions of RSA 31:95-c and abolish the Police Outside Detail Special Revenue Fund that restricts revenues from Police Department special details for the purpose of compensating personnel and administrative costs. 100% of the balance remaining in the Police Outside Detail Special Revenue Fund as of March 31, 2006 will lapse into the Town's General Fund.

And, furthermore, to see if the town will vote to create a revolving fund pursuant to RSA 31:95-h, for the purpose of police special details. All revenues received for police special details will be deposited into the fund, and the money in the fund shall be allowed to accumulate from year to year, and shall not be considered part of the town's general fund unreserved fund balance. And furthermore, to appropriate fifty six thousand dollars (\$ 56,000.00) into this fund from unreserved fund balance. Such sum represents the balance from the discontinued prior Police Outside Detail Special Revenue Fund. The town treasurer shall have custody of all monies in the fund, and shall pay out the same only upon order of the governing body and no further approval is required by the legislative body to expend. Such funds may be expended only for the purpose of compensation of personnel, administrative costs, vehicles and other related safety equipment for police department outside details for which the fund was created. No amount will be raised by taxation. This appropriation is in addition to the operating budget. (Majority vote required)

ARTICLE 12

Are you in favor of the adoption of Article 12, as follows:

Shall the Town raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein totaling six million nine hundred ninety two thousand five hundred forty dollars (\$6,992,540). Should this article be defeated, the operating budget shall be six million six hundred eighty thousand fifty seven dollars (\$6,680,057) which is the same as last year with certain adjustments required by previous action of the Town or by law or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. (Majority vote required.)

ARTICLE 13

Are you in favor of the adoption of Article 13, as follows:

To see if the Town will vote to increase the number of Library Trustees from three (3) to five (5) pursuant to RSA 202-A:6. If this article is enacted, two additional trustees will be elected at the 2007 Annual Town Meeting to staggered three year terms ending in 2009 and 2010, respectively. (Majority vote required.)

ARTICLE 14

Are you in favor of the adoption of Article 14, as follows:

(By Petition) To see if the town will vote to study the merits of a Heritage Commission. The Heritage Commission shall have five (5) members to be appointed by the Board of Selectmen plus one exofficio member who is a member of the Historic District Commission (HDC) and who is appointed by the HDC. The Heritage Commission may have up to three (3) alternate members appointed by the Heritage Commission. All terms shall be for three years, with the initial appointments staggered.

Towns may establish heritage commissions for the proper recognition, use, and protection of resources, tangible or intangible, primarily man-made, that are valued for their historic, cultural, aesthetic, or community significance within their natural, built or cultural contexts. The Heritage Commission would not replace the HDC. It would operate town-wide, whereas the HDC only operates within the Rye Historic District. *Art.* 12: A Yes vote would appropriate \$6,992,540 as approved by the Selectmen and the Budget Committee, to adequately fund the Town's 2006 Operating Budget.

A <u>No</u> vote would not fund the 2006 Operating Budget as proposed by the Selectmen and Budget Committee, but rather, would result in the adoption of a default budget of \$6,680,057.

Art. 13: A <u>Yes</u> vote would add two additional members to the Board of Library Trustees.

A <u>No</u> vote would keep the number of library trustees at three.

Art. 14: A <u>Yes</u> vote would allow the town to study establishing a Heritage Commission.

A <u>No</u> vote would mean the town would not study such a commission.

The Heritage Commission shall have advisory and review authority as set forth in RSA 674:44-b, I., and it shall have the authority as set forth in RSA 674:44-b, II, to acquire, in the name of the town, but subject to the approval of the board of selectmen, such interests as may be necessary to acquire, maintain, improve, protect, limit the future use of, or otherwise conserve and properly use the cultural resources of the town, and to manage and control the same.

ARTICLE 15

Are you in favor of adoption of Article 15, as follows:

(By petition) To see if the Town will vote to allow the Rye Selectmen to broadcast town news on Comcast's local public cable channel. The broadcast will appear as text messages and will be scheduled as to maintain current Portsmouth Broadcasts. Rye news would be aired at a time when Portsmouth news is idle. While there is no cost to the Town of Rye, the passage of this article will result in a monthly franchise related cost to Comcast customers to reflect a one time purchase of dedicated software and hardware required to air Rye news. Planning Board Explains Article 3

For voting season this year in Rye, the Planning Board has several zoning amendments for your consideration. Here is a summary of the items you will be voting on March 14. An important one is the creation of a new section of the zoning ordinance that would allow small-scale senior housing in Rye—see item 3 below.

1. Lots with two or more dwelling units [Article 3, Amendment 1]

This amendment clarifies the description of lots with two or more dwelling units to certify the lots are nonconforming and reinforces the rule that expansions of these nonconforming lots is prohibited. This amendment was proposed and approved by the Planning Board.

2. Common area requirements for condominium conversions [Article 3, Amendment 2]

This amendment requires that 90 percent of the parcel area, except land designated for parking, be reserved as common area in condominium conversions involving detached dwellings. This amendment was proposed and approved by the Planning Board.

3. Retirement Community Developments (RCDs) [Article 3, Amendment 3]

This item will encourage the construction of small residential neighborhoods in Rye designed to meet the needs of people 62 years of age and over. An RCD may be located in any zoning district, except for the Rye Beach Precinct. It will allow a minimum of eight dwelling units, but not more than 16 dwelling units, on a minimum lot of 10 acres. A bonus may be allowed to raise the total number of units up to 22 if the developer prices 15 percent of the units as aff o rdable. This amendment was proposed by and approved by the Planning Board.

4. Golf courses in the Single Residence District (By Petition) [Article 3, Amendment 4]

This amendment, which is by petition, has been **disapproved** by the Planning Board. It would remove the amendment passed in 1999 which allowed golf courses as a permitted use in the SR district.

Update on Webster at Breakfast Hill. The Planning Board has kicked off the special committee that will do an in-depth evaluation of the zoning change proposed to allow the expansion and continued presence of Webster in Rye. This committee will report back to the Planning Board by September 1, 2006 with information to allow an informed decision on subsequent possible zoning changes for a continuing care retirement community in Rye.

might be necessary while this building is still our primary place of business. Our Town's history of occupancy of this building has been one of integrity and protection. Today, despite the need for space that has come to all towns as the result of growth and the computer age, the beautiful front staircases, the tin ceiling on the second floor and the stage, complete with its proscenium arch, are all still intact. While on its face, acceptance to the registries imposes no restrictions; one selling point is that the Town can apply for restoration and maintenance grants. It is the belief of the Board that the limitations come with acceptance of state and/or federal funding.

Article 14. (By petition) asked voters to establish a Heritage Commission. Following lively discussion, this article was amended to see if the town will vote **to study** establishment of a Heritage Commission.

Article 15. (By petition) asks Selectmen to allow broadcast of town news on Comcast's local public cable channel. Our Communications Committee, co-chaired by Susan Rizkalla and Michael Schwartz, has been seeking to diversify the means available for you to become informed about municipal meetings, special events and deadlines. This must not place a burden on Town Hall employees. If voters agree to give this proposal a try, it will be put in place and updated by the Committee. No money is requested in the budget for this project.

Earlier this year, the Selectmen, with the assistance of Drew Doherty, approved a Web Site Policy. We also appointed Drew as Rye's Website Director. As a volunteer, Drew has provided us with an invaluable service for a number of years. The Communications Committee will only place items on Channel 22 that have been approved for the Rye Web Site and they will be aired at specified times in a continuous loop, probably two or three times each day. When

Rye news is being aired, Portsmouth transmission will not be seen.

Under our current franchise, Comcast is obligated to allow the Town of Rye to broadcast over the public channel. The reason for the Warrant Article is that the obligation cannot be activated until special equipment is purchased to include a computer and scheduler to receive our information and time the Rye broadcasts. Comcast must make this one-time purchase in order to insure compatibility with their equipment. If approved, 9 cents will be added to the bill of every Rye cable user each month for 30 months, a total of \$2.70.

Article 16. (By petition) If approved, this article will deliver via e-mail the same information as Article 15.

Emergency Management Update

On December 29, 2005, the Selectmen received the resignation of Mark Zartarian as Rye's Director of Emergency Management effective at noon on December 30, 2005.

Aware of an Emergency Management exercise scheduled for January, it was imperative that the opening be filled immediately. Police Chief Alan Gould was asked to serve as Acting Director of Emergency Management and he accepted this responsibility effective January 1, 2006.

On January 23rd, the Board appointed Fire Chief Rich O'Brien as Deputy Director of Emergency Management. Kenneth Moynahan continues to serve as a Deputy Director. These appointments provide the Town with strong emergency management team leadership that includes both full time employees and residents of the community.

Planning/Zoning Administrator Resigns

The resignation of Planning/ Zoning Administrator John Elsden, effective Friday, February 17, 2006, was received and accepted with regret on February 6. John has worked diligently on Rye's behalf during his time with us.

House Numbering

It has come to our attention that currently many properties in our town do not have house numbers displayed in a manner that provides "at a glance" identification for emergency purposes. In a true emergency, every second counts. Please ask yourself: Can my house number be seen from the street both day and **night?** Is the number at a location that police, fire apparatus, or ambulance driver would expect to see it? Is it large enough and legible enough (script is often difficult to read from the street)? If the number has been in place for a long time, have bushes or trees grown in to obstruct it from view?

If you have questions with regard to appropriate size or placement, please contact the fire station for assistance.

Recycling in Rye Is Mandatory

Several trends appear to be driving the cost upward for the disposal of our collective trash. Tonnage of recyclables is down somewhat, perhaps the result of numerous manufacturers switching from glass containers to plastic. Cost of disposal is up. The tipping fee at Turnkey has taken another jump. Fuel cost to transport is another factor. It appears that a number of households have cancelled their commercial haulers in favor of coming to the Recycling Center. But some residents may not realize that recycling is mandatory. This may also be the case for those who have recently moved to Rye. In addition, certain items such as TVs, computers, appliances, and other household items not only do not go into the packer but also require a disposal fee. Protect your right to use the recycling area; ask if you are uncertain.

Preparation of your recyclables will save you and your fellow recy-See Selectmen, page 8

Mosquito Control Report

There is increased awareness in the Town of Rye and other coastal communities this year with regard to mosquito control because of the rising threat of mosquito transmitted illnesses such as Eastern Equine Encephalitis (EEE) and West Nile Virus (WNV). State and local authorities will be monitoring the situation to inform residents as to the proper precautions. The 2006 Rye Mosquito Control budget request has been increased to reflect the cost of additional inspections, monitoring, and treatments related to the threat of EEE and WNV.

The Town of Rye is in an advantageous position with regard to mosquito control for several reasons. Rye already has an established mosquito control program that has been very effective. Municipal Pest Management has successfully provided services to Rye for several years. The owner of the company, Mike Morrison, has the professional training and more than twenty years of experience to make him uniquely qualified for the job.

Because Rye has been proactive and adopted a well-managed mosquito control program we have the opportunity to partner with Ducks Unlimited and the NH Coastal Program. Working with these organizations will enable the Rye Mosquito Control Commission to develop a long-term Wetlands Management Program.

Why is wetlands management an important part of mosquito control?

Effective wetlands management can significantly reduce the size of mosquito breeding sites. If the marsh no longer is an important breeding site it no longer needs to be treated, thus saving time and money. Our neighbors in Greenland have recently benefited from this type of program.

What is wetlands management?

The primary goals of wetlands management are restoring pool habitat, eliminating invasive plant species,

clers time at the facility. In advance, separate the newspapers from glossy ads, cut or collapse the cardboard, and sort colored glass if you have a large amount. Those behind you in line will appreciate your efforts.

The bottom line is that due to the diligence of those using the recycling area, many hundreds of thousands of dollars have been saved over the years. Periodically, it is necessary for each of us to renew our efforts by becoming aware of new opportunities for recycling, revisiting household organization for recycling, and reminding family and informing guests that **recycling is mandatory in Rye.**

and reducing the need to larvacide salt marsh sites. Restoring pool habitat allows minnows, which consume over 90 percent of the mosquito larvae, to become permanent inhabitants of the marsh. Eliminating invasive plant species (Phragmites) that cause water stagnation reduces standing water in which mosquitoes breed. These methods are effective and their beneficial results are well-documented.



LARVAL SURVEYS BEGIN IN APRIL

Starting the first week of April, the town's contractor for mosquito control, Municipal Pest Management Services, Inc., will begin surveying the stages of mosquito larvae in marshes and standing water areas. These surveys determine when treatment of mosquito breeding sites should begin. Residents who have concerns about standing water and mosquito breeding sites are urged to notify the Mosquito Commission by calling the Selectmen's Office at 964-5523.

Why do we need wetlands manage - ment?

Healthy coastal wetlands are productive ecosystems that are home to hundreds of animal and plant species. A similar shield was erected on Star Island in 2005.





You may not know that your Police Department is active in the schools. Through the cooperation of the

Fire Department Reminds Residents to Watch for the "Invisible Killer"

The Rye Fire Department would like to remind all residents to re-familiarize themselves with the "Invisible Killer"—carbon monoxide. During the winter months when we use our furnaces and heating units, the risk of being exposed to deadly carbon monoxide gases increases. Carbon monoxide is a byproduct of fossil fuel (wood, oil, gas, gasoline, kerosene) combustion. It is colorless, odorless, and poisonous. The gas enters the body through the lungs where it's delivered to the bloodstream. Carbon monoxide prevents the blood from carrying and using oxygen properly—starving the body's brain and organs.

The symptoms of carbon monoxide poisoning begin with flu-like symptoms (but without fever or runny nose). Symptoms may include:

- Headache
- Fatigue
- Shortness of breath
- Nausea
- Dizziness

If you feel you have been exposed to carbon monoxide, get to fresh air immediately. Call 9-1-1, or if you are unsure if you have been exposed to the poisonous gas, you can call either the Northern New England Poison Center at 1-800-222-1222 or the fire station at 964-6411.

The best way to protect yourself from carbon monoxide poisoning is through detection and prevention. Every structure that is heated with a furnace that burns fossil fuels should have a carbon monoxide detector installed. Always install the units according to manufacturer's recommendations AND in a location where it will be heard by occupants that may be asleep. You can prevent carbon monoxide from entering your home by ensuring that all appliances and heating systems are installed and serviced by professionals, and by having your furnace and chimney cleaned and inspected annually.

The Rye Fire Department is proud to announce the promotion of two of its employees. Ronald Hordon and Jeffery DiBartolomeo have been promoted to the rank of Fire Lieutenant. The latest promotions are in keeping with our mission and vision to ensure that the community can receive prompt, high-level service regardless of the time of day or night. Once again, I would like to thank the town residents for their continued support of a Fire Department they can be proud of.

Consider the Building Department in Planning Spring Projects

Now that Spring is upon us and thoughts turn to landscaping, pools, sheds, and fences, don't forget to come in and share your excitement with us! You need a building permit for all of the above, and the patio surrounding your in-ground pool counts as a "structure" and needs to meet setbacks too! The fence around the pool (above and in-ground) needs to be at least 5 feet high and erected prior to the water being put in your pool.

When you are planning your plantings, make sure you are aware of where your property line is. And no, it is not to the edge of the pavement. Your property line is generally 25 feet from the centerline of your road. Although we appreciate you trying to make the town right-of-way more beautiful with your plants, it is town property and your efforts may be damaged by the snowplows in the winter. But thanks in advance for maintaining and mowing the town right-of-way. All efforts towards making our town beautiful is appreciated.

When planning your spring project, prioritize three things: zoning, zoning, and zoning. Once you discover zoning is okay, check your septic plans. Hopefully we have these plans for you to review in the office. Otherwise, you will need to prepare some new ones before a building permit can be issued, if additional living space is part of your project.

Bathrooms in basements sound convenient, but can wreak havoc on your septic system. State law requires that the injector pump, which

is typically required in basement bathrooms to pump the sewage into your septic tank, be connected into a septic tank with twice the volume otherwise required. You can also just add another septic tank or compartmentalize the existing tank.

And for all the commercial businesses out there, any change in the use or tenant requires permission from this office! We have a form you can complete that will be reviewed for compliance. This step was created to avoid cluttering the Planning Board with simple, straightforward applications. However, we may decide your new tenant or use does not comply with zoning or does require a site plan review by the Planning Board. Please do not assume your new tenant will be permitted.

New, changed, and refaced signs all need permits. We have a new sign permit application that clearly states the zoning rules, including political signs. You do not need a permit from us for political signs; they just need to be on placed on private property with the property owner's permission.

Remember, the town right-of-way is owned by the town and we do not give permission for political signs. Also, Foyes Corner is a magnet for signs but the majority of the land with the ability to support a sign is private property, including the parking area located to the east of Foyes Corner, and you must get the owner's permission prior to placing a sign there. Last year the corner became cluttered with signs. We all need to be respectful of private property owners.

General questions can be addressed through Sue Dunfey, Office Assistant. Office hours are Monday through Friday, 8:00 to 12:00. The afternoons are reserved for inspections, appointments, and research. Thank you for your cooperation and we all hope you enjoy the upcoming season!

Rye Water District to Hold Annual Meeting

The Rye Water District's Annual Meeting will be held on Saturday, March 25 at the Rye Junior High School at 10:00 a.m.

Items planned for the agenda include:

—warrant articles to raise and appropriate the sums of:

• \$50,000 to be placed in the existing capital reserve fund established for the purpose of replacing the District's existing distribution system's buildings and equipment.

• \$5,000 to be placed in the existing capital reserve fund established to meet the costs of unanticipated expenses during the fiscal year.

• \$5,000 to be placed in the existing capital reserve fund established for the purpose of purchase, repair, modification, or replacement of equipment and buildings that support operation of the water distribution system.

—election of a Commissioner (3year term).

—to see if the District will vote to raise funds to defray the Water District charges for the ensuing year.

Projects

In 2006 we are planning to improve service on Odiorne Drive by replacing the existing water main and extending a new section of water main to the end of the street.

Assessing Department Discusses Valuation and Exemptions

The spring tax bills will be in the mail around May. For most taxpayers, the valuation is one half of last fall's bill. Exceptions are those properties where building construction has taken place on previously vacant land or where structures on improved land were demolished and replaced by new. The spring bill for such will reflect the status of the construction as of April 1, 2006. Also included will be revisions to update or correct data implemented by state requirement for one-quarter of the buildings in town to be remeasured and reinspected over a four-year cycle. That ongoing process commenced in 2003 and will continue annually. Updates will be shown on this first bill for those properties that were visited. Should the owner disagree with the assessment, the appeal period commences upon receipt of the Fall tax bill up to March 1, 2007.

The Assessing office reminds property owners who appealed their 2005 valuation and filed an abatement application by March 1, 2006 that the Town has until July 1, 2006 to respond. If dissatisfied with the decision, you have until September 1, 2006 to file further with either the State Board of Tax and Land Appeals or Rockingham County Superior Court. Local appeal must have been made first in order to later file with the state or court.

CLIP AND SAVE

The State Department of Revenue Administration (DRA) has commenced its independent review of the Town's Assessing Department compliance with equalization standards and practices in January and February 2006. A sampling of properties had been randomly selected by the DRA to be remeasured and reinspected for accuracy. This process has been completed and the results are pending. The DRA procedure is separate from the four-year cyclical review being conducted by the Town.

We would also like to inform persons eligible to apply for the elderly exemption that the application is available at the Assessor's office and must be submitted by August 1, 2006. The applicant must be at least 65 years of age as of April 1 of this year and have been a resident of New Hampshire for the prior five (5) years. Income limitations are \$40,000.00 for a single person, \$59,900.00 for married and total assets not in excess of \$199,000.00 exclusive of the residence. You do not have to apply anew each year.
