Goodwin Conservation Land

Chair McFarland explained that they are behind on this property. She asked for two volunteers to walk this property by the end of October with Sally King.

Members Truslow and Shepcaro volunteered. Member Truslow will take the lead.

Sea Glass Conservation Land

Chair McFarland reported that they had an attorney meeting and it seems that it is the homeowner's responsibility. Chair McFarland noted that she spoke to a landscaper that the Commission has used in the past. He is getting a quote for what it would cost to get a very thick sawdust that would be from 6 inches to 3 feet, which would be located on the left of the entrance. He is also going to put together a restoration plan for that area. She also mentioned some kind of a rock demarcation, so that people know where to walk. They also need a site walk to walk the entire boundary, because there is irrigation on the conservation easement and lawns. She asked if she could get a quorum to do a site walk at Sea Glass Conservation Land sometime next week.

C. Goss Barn

Chair McFarland had someone look at the buckling/split boards on the east and west side. She has an estimate on replacing some of the split boards and nailing down some of the others. The east and west side have not been painted since 2014 and it is now getting dryer. She has also gotten painting estimates; however, the painters are all booked, so no one can take on the job at this time.

Member Shepcaro reported that she has someone that could give them an estimate and possibly do the job.

The repair work will be done by the end of October.

This is all part of Goss Farm - Phase Two.

Chair McFarland asked if the Town Forest Management Plan has been finalized and if it is online yet.

Member Shepcaro stated that it is not online yet. They need to get back to Charlie Moreno with a go ahead on the printing and binding and then it can be posted online. She will contact Mr. Moreno. She will also contact Tracy Degnan to see how see wants them to send it to RCCD.

Chair McFarland reported that she will not have any means of electronic communication on September 24th and that is the ZBA meeting where the Commission has four applications; 4 Washington Road, 1&3 Cable Road, and 24 Glendale Road. She asked if anyone could sit for the meeting. Member Garvan agreed to sit in.

Member Garvan brought up that the Forest Management Plan is done and approved. The Commission has a lot of work to do. There was a lengthy discussion on signage, blazing the trails and where to use volunteers and students from the Rye Junior High to help. Member Oliver will get the information in the next newsletter.

Chair McFarland recommended that members Truslow, Shepcaro and Garvan form a subcommittee and get together to talk about the work plans.

Member Shepcaro reported that she had 'Seacoast Tree' look at the large oak at Goss Farm that has a large limb that is dead and being held up by a cable. Sally King wants the hawthorn tree also looked at because it is starting to split. Member Shepcaro will set up a meeting with the tree company to look at that tree as well.
