#### 1) Attestation and Roll Call:

#### 2) January and February Meeting Minutes Approval

#### 3) Conversation with Jay McFarland on NH Zero Emission Vehicles

In response to an article in Seacoast online about Kennebunkport leasing 2 electric vehicles for town use ("As a result of the Hyundai rebate and funds from Efficiency Maine, the town would pay nothing for the lease, Smith said."), we invited Jay McFarland of Hampton Ford-Hyundai to our meeting. While the incentives are different in Maine than in NH we thought it would be interesting to learn more about the feasibility of leasing electric vehicles in the future. Jay explained that because NH has not adopted zero emission standards, it can be harder in NH to test drive or purchase zero emission vehicles. Thirteen states have adopted these standards - Massachusetts, Vermont, Maine, Rhode Island, Pennsylvania, New York, Connecticut, Washington, Oregon, New Jersey, Maryland, Delaware, Colorado and also the District of Columbia. NH is surrounded by states that have adopted the standards. Manufacturers of zero emissions vehicles send 50% of their inventory to the states that have adopted zero emissions standards and the other 50% go to the remaining states. There is proposed NH legislation that would help enable emissions standards but implementation will take time.

Jay also noted that there are many new vehicles in development including electric vehicles tailored to delivery services. These vehicles need less range than a personal vehicle may need making them more affordable for businesses.

#### 4) Update on Energy Related House bills

The bills the Energy Committee has been following are:

- HB 213 This bill would effectively reduce NH's Renewable Portfolio Standard (RPS) from 25% in 2025 to just under 9% in 2035. Status - Retained
- HB 225 This bill would reset net metering credit to wholesale prices. Status Killed
- HB 315 This bill had the potential to derail RSA-53A, the "Community Power" law. This bill
  has been amended with much work by the sponsor and those who opposed it in its original
  form. As amended, the bill preserves Community Power authorities and improves the existing
  statute. Status In Committee
- HB 549 This bill would reduce the systems benefit charge and weaken the proposed Triennial Efficiency Plan. Status Retained

#### 5) Rye Master Plan

The Energy Committee is aware that Rye is beginning the process to update the Master Plan. We understand that the Planning Board is taking the lead and Howard will call Kim Reed for further details. In the interim, we are reviewing the prior Energy chapter and looking at samples from other towns so that when the process begins we will be informed.

#### 6) Lighting Upgrade Update

The lighting upgrade at the library and the town garage are completed. A lightning upgrade plan for the Public Safety building was provided in 2019, but the work was never approved. Howard did a walk-through of the building with Chief Walsh. Issues from the last lighting upgrade were reviewed. The Energy Committee is hoping the revised upgrade can be approved and completed this year with attention paid to resolve previous issues.

#### 7) School Solar PPA

The School Board is reviewing the revised contract from Revision. There is a virtual informational meeting planned for May 8. The School Board, Revision and Kevin Brandon will likely lead the presentation. The Energy Committee will attend and provide any support necessary.

#### 8) New Business

The Energy Committee has been working with municipal entities to make sure they are purchasing their energy supply at the best rate possible. Currently Eversource is offering the lowest rates but several buildings had contracts with other suppliers that previously had better rates. The renewal of those contracts is being explored.

The Community Power Coalition of New Hampshire (CPCNH) is holding an informational meeting for municipal and community leaders on Community Power. It is on March 18 from 10:30 - 12. CPCNH is a non-profit organization formed to help foster resilient NH communities by providing education, engagement and technical assistance for Community Power.
