IV. Review of Minutes from January 2021

VI. Demolition Review Committee Update

Member Choate reported that there has not been a Demolition Review Committee meeting since the last Heritage Commission meeting. The Planning Board voted to send to the warrant the request to have a notice sent to abutters prior to any Demolition Review Committee public hearings. There are currently no applications pending before the Demolition Review Committee.

VII. Historic Structure Taskforce Update:

Member Choate reported that they have met twice by phone and have another meeting scheduled Monday. There are nine people involved. They have solicited information from the New Hampshire Preservation Alliance. They are trying to do three things. One is how to distribute the pre-1900 house building information that has already been assembled through Alex Herlihy and Lydia Tilsley's efforts, in a form that is readily accessible on the internet. Second, would be to accumulate, assemble and digitize information on structures from 1900 to 1950-ish. There is currently no information in this area yet. Third, would be to come up with ideas to incentivize people to maintain their historic buildings in a way that does not so alter them that they are unrecognizable from their original history, or in the worst case demolish them.

Member Herlihy thanked Janice Ireland for pointing him in the right direction in getting documentation on all homes built between 1900 and 1950. She told him that the Assessing Office has that information. He asked Joanne in the Assessor's office for the information and she was able to print off three documents that give the address and date built of all houses in Rye. The first document was pre-1900. There are 287 properties in this category. He and Lydia have about 210-215. So, they are continuing to work on that. The second document is 1900 and 1950. During this period there are 800 house that were built in Rye that are still in existence today. Homes built between 1950 and 2021 was 1,973.

Member Choate pointed out that the challenge will be what type of incentives, recognitions or non-legislative things will encourage people to maintain, preserve, and enhance their house that has historic value, rather than just taking on a renovation project that alters it from its original style.

VIII. New Business

A. Any updates re: Gazebo repairs/Restoration Costs

Member Herlihy reported that he should have some information for the March meeting. He is trying to get some estimates from some local builders.

Chair Walsh suggested that they hold off any further discussion on this matter until March and then move ahead with finalizing the fundraising mailer.

Member Choate congratulated Member Arnold on her article in Rye Reflections on the Gazebo. He suggested that when the Commission does the fundraiser, they consider the cost of buying and installing a street-side historic marker.

Chair Walsh pointed out that this leads into the Discussion that he has on the agenda regarding the plaque for the Town Hall: re National Register of Historic Places. He will hopefully have more information as to who does this type of thing by the March meeting. He added that the State was not really very helpful in the matter. They gave him a few names of companies, but either they did it for larger projects or were extremely expensive. He has reached out to a few companies and is now waiting to here back from someone in Swanzey, NH, that sounds promising.

Note: Selectman Epperson joined the meeting at this time.

C. Graveyard Adoption

Chair Walsh reported that Mr. And Mrs. John and Renee McCune have reached out to Member Herlihy and are looking to adopt grave yard #38 at Brackett Road. They are excited to take over this graveyard; to clean it up and to see that it is maintained.

Member Arnold asked Member Herlihy if the McCunes would be willing to be interviewed for an article the she will write on the Adopt a Graveyard Program.

Member Herlihy promised to reach out to them and ask and give them Member Arnold's contact information.
