

**TOWN OF RYE**  
**MOSQUITO CONTROL COMMISSION**

**I. Call to Order**

Chairman Aspinwall called the meeting to order at 5:07 p.m.

**III. Old Business**

**1. Resident Concern**

Chairman Aspinwall noted the Town received a call from a concerned resident at 112 Grove Road in regards to people who were larviciding near his property. They were crossing his property to access their truck; however, they were not treating his property. The resident does not want pesticides on his property. He wanted to make sure this was a just a mistake and is not going to occur all through the season. Sarah MacGregor, from Dragon, is aware of the situation and she will do her best to make sure there are no more issues.

**2. Status of Greenhead Traps**

Chairman Aspinwall noted that Ms. MacGregor has been working on the greenhead traps. The traps do not have to be out in the marsh until the third week in June. The greenheads are soil maggots and start out in the mud in the marshes. They survive on the organic material in the mud and pupae into greenheads, which are nasty biting insects. The intent is to have 144 traps in the marshes. He continued that he has spoken with a resident at 21 Brackett Road who has requested traps around his property, as this is a prime territory for greenheads and mosquitos.

#### **IV. New Business**

##### **1. Monthly Activity Reports**

Sarah MacGregor sent copies of the activity report to the Commission for their review. The report noted the date and location of the surveys and larvicide applications. The general procedure is that a survey is done and if activity warrants it a treatment is done with larvicide or with an agent that is a paraffinic oil. The report shows that Dragon Mosquito Control is on schedule for services.

Chairman Aspinwall reviewed the invoice from Dragon Mosquito Control dated May 1<sup>st</sup>, which looked consistent with what was projected and budgeted.

**Motion by Tom Aspinwall to approve Invoice 29814 in the amount of \$8,000 for Dragon Mosquito Control. Seconded by Denis Lipman. All in favor.**

Commissioner Lipman reviewed the locations where he has put up tick posters in Town. There was discussion on other possible locations for the poster.
