**I. Call to Order and Pledge of Allegiance**

Chair Losik called the meeting to order at 8:30 a.m. and led the Pledge of Allegiance.

**II. Review Chapters**

**a. Transportation**

The committee reviewed the editorial changes made by Chair Losik on Chapter 6, Natural Resources.

Highlights:

- Page 6-2, under 6.3 – It was agreed to remove “and Map T-1”. It was also agreed to remove “and road miles”.
- Page 6-6, *Parking Along Route 1A* – Planning Administrator Reed agreed to confirm the date of the study being referred to.
- Page 6-9, - It was agreed to remove the websites listed at the bottom of the page.

The chapter will be presented to the Planning Board at their next monthly meeting.

**b. Natural Resources**

Highlights:

Page 7-2:

- Under 7.2 – It was agreed to name Figure 7-2 “2002 Visioning Session Public Comments”. Under that will be “Comment Summary”. *(This will be the same for the table on page 7-3.)*

Page 7-3:

- Wooded Lots (table) – Purposes are viewing, noise mitigation, issue of burning brush, forest management.
- Table at top of page – Heading will be “(Dates) Climate Session Public Comments” with “Comment Summary” to follow. *(Planning Administrator Reed to confirm the dates.)*

- Coastal Resources, Under A, the Beach Access Report (2011) will be posted on the Town's website.

Page 7-4:

- Under A (before list of beach access points) it will read – With approval from the Selectmen, beach access points for public use are at the following locations as described:

Page 7-7 :

- Before Figure 7-3 add “As shown in Figure 7-3”.
- Add a box around Figure 7-3
- It was agreed to take out the DES reference.

Page 7-8:

- The committee discussed Member Carter's edits he presented.
- It was agreed the word *Phragmites* should not be italicized.

Page 7-9:

- Under 7.4 – The first sentence will read: Refer to the Conservation Lands and Town Owned Property Map (2005) in Appendix A.
- Under 7.4 – The committee reworded the large paragraph at bottom.

Page 7-10:

- It was agreed that the ‘Rye Town Forest Trails Map’ will be ‘Figure 7-4’.

Page 7-11:

- Under A – Farmland Type and Acreage will be boxed and will be ‘Figure 7-5’.

The committee finished their review and will continue with Chapter 7 at the next meeting.
