- 1 day high number 660,000 gallons pumped
- Month 7.2 million gallons pumped

#### Working capacity:

- Per Day 478,000 gallons (average bedrock wells)
- Total 1,155,000 gallons (Garland plus bedrock average)

#### VIII. Old Business:

- The final comments from Wright Pierce's review of the South Road Development have been received and will be sent to the Planning Board, Danna Truslow and Tim Stone, Stone Environmental (representative for the developer). The commissioners plan to attend the next Planning Board meeting on January 10<sup>th</sup>.
- Ken Aspen will be working on taking samples in January for PFC's.

#### IX. New Business:

• The Budget is being prepared for 2017. Ken Aspen is working on coordinating expenses for 2017 projects and activities. The budget will be reviewed at the commissioner's work session.
