II. Review of Encumbered Funds

Chair Clifford noted that the Commissioners found it necessary to unencumber the funds that were encumbered at the December 2^{nd} meeting for the new generator.

Motion by Art Ditto to rescind the prior vote to encumber \$55,000 for the purchase of a generator for the Bailey Brook/Cedar Run Well Complex. Seconded by Ralph Hickson. Roll Call: Tom Clifford – Yes; Art Ditto – Yes; Ralph Hickson – Yes Motion passed

III. Budget Update

The Commissioners will be meeting on December 30th to work on the 2021 Budget. There were no questions on the budget at this time.

IV. Other Business

Chair Clifford reported that Zach Malpass called him to find out what was going on with the easement process. He told Mr. Malpass that he spoke with Attorney Bill Scott right after the Commissioner's meeting on December 2^{nd} . At that time, Mr. Malpass had said that he did not want to do any business with anybody in the Town, until his issues with the Town were resolved. Chair Clifford noted that he relayed this information to Bill Scott and told him to hold off on doing any further effort this year. He is not sure where the District stands with the other abutter Mr. Bean.

Commissioner Ditto commented that he believes they are pretty much set with Mr. Bean. If the well is permitted, it is just a matter of adjusting the sanitary radius and dropping the one for the existing well. Mr. Bean will be given a right-of-way to access his property. This work will probably also be done by Attorney Scott.

Commissioner Hickson noted that Attorney Scott finalized the agreement with Mr. Bean. He asked Chair Clifford if Mr. Malpass has finished his business with the Town.

Chair Clifford replied no. He continued that Mr. Malpass is not against giving the District a sanitary radius on his property. He just does not want to do any business with the District until his business with the Town is resolved.

No further business came before the Commissioners.
