# II. PUBLIC HEARING – Town-wide Trick or Treat date change to October 31, 2020

The purpose of this hearing is to allow public comment on the Health Officer's recommendation to the Board of Selectmen that in accordance with RSA 147:1 I, the date for Trick or Treat in Rye be changed, this year only to October 31, 2020, to match surrounding communities in order to help prevent the spread of COVID-19.

Chair Winslow read the notice of the Public Hearing. He explained that by moving the date the Town will not be encouraging the children from surrounding towns to come to Rye and will encourage Rye children to stay in town and not go to other towns for Trick or Treat.

Chair Winslow opened the Public Hearing at 4:08 p.m. Hearing no public comments; Chair Winslow closed the Public Hearing.

Selectman Epperson stated that he felt that this is an appropriate move. He pointed out that the other communities in the area are making this consideration for the kids. For the sake of the children and in the attempt to getting back to some sort of normalcy, the Board should do this.

Chair Winslow agreed and recommended that the protocol given by Chief Walsh should be sent out and followed by the homeowners who are planning to give out candy. The protocol also outlines what the Trick or Treaters should do to stay safe.

The ways the protocol will be publicized will be:

- On Social Media
  - Face Book
    - o Both Police and Town Hall
- On the Towns Website
- On the Police Website
- Flyers at the Town Hall and the Transfer Station
- Ad in Portsmouth Herald

Chief Walsh presented the protocol that was developed by Dr. Snow, Chief Cotreau and himself to the Board as follows:

## **Homes who participate in Trick or Treat:**

- Only give out pre-wrapped items
- Wear a mask when handing out and collecting treats
- Give out items outside or in a way to keep 6 feet of distance (such as behind a storm glass door) and replace treats before each round of visitors
- Do not hand treats directly to kids
- Put out hand sanitizer

## For Trick or Treat participants:

- Parents and kids should be in small groups, preferably family members only and within your neighborhood
- Avoid large groups and going inside homes
- Maintain social distancing while Trick or Treating
- Carry hand sanitizer (gloves are not recommended)
- Wear protective masks (this may be part of a costume if it's cloth)
- If a home does not want to participate, please leave all front lights off

# STAY AT HOME IF YOU ARE NOT FEELING WELL OR HAVE HAD CONTACT WITH SOMEONE WHO HAS COVID-19.

Note: Selectwoman Bradshaw joined the meeting at 4:12 p.m.

Selectwoman Bradshaw noted that Kittery, ME is still having Trick of Treat on the 30<sup>th</sup> of October.

Chief Walsh stated that North Hampton is the only New Hampshire town in the area that is having it on the 30<sup>th</sup>.

Motion by Phil Winslow to accept Dr. Snow's recommendation, in accordance with RSA 147:1 I, to move the date for Trick or Treat in Rye this year only to October 31, 2020 to match surrounding communities in order to help prevent the spread of COVID-19. In addition, the Town will put out information relative to participation guidance from the Police Chief. Seconded by Mae Bradshaw.
