- **Steven Borne, 431 Wallis Road**, noted that there seems to have been some select board meetings that were scheduled with no streaming; such as, the one on January 15th. Also, he thought that the deliberative session was scheduled for February 6th, but the posting today stated that it is on January 30th. The MS-7 was posted but not the spreadsheet of the budget that the public normally gets. The November 5th all day workshop is listed in minutes on the website but there is nothing there.

VII. DISCUSSION ITEMS

A. Deliberative Session Discussion

Moderator Eaton reminded the Board that at the last meeting they had voted to schedule the deliberative session for February 6th and the Election for March 9th. It was also decided to postpone the deliberative session every three days until they reached June 5th and the election every two weeks until they reached July 13th. Also, they had been hoping that the legislation would set some protocol for towns to follow. The legislation had an election committee meeting and they considered SB-2 and took no action. However, the same day the Governor issued Executive Emergency Order #83. This order basicially adopts the wording of SB-2. It allows the governing body to postpone the election to the second Tuesday of April, May, June or July. The second Tuesday of July is the 13th, which is what the Select Board had already focused on as the date to postpone too. Executive Emergency Order #83 puts the authority to postpone the election with the Select Board. He recommended that the Select Board vote to postpone the deliberative session until June 5th and the election until July 13th.

After consulting with the Town Moderator and the Town Clerk the following motion was made:

Motion by Phil Winslow to postpose the Deliberative Session until June 5, 2021 and the Town Election until July 13, 2021 in accordance with the Governor's Emergency Order #83. Seconded by Mae Bradshaw.

C. Cell Tower Update

Town Administrator Bergeron reported that the Building Department has approved the building permit for the site work and preconstruction. Verizon is now working on the tower and foundation design so that their construction division can bid the project out. They are looking at early spring to start the construction. Planning Administrator Reed has contacted Ken Weaver about a date for withdrawing the Brackett Road application. She is waiting to hear back from him. In the meantime, the shot clock has been extended until March 31st.
