Recording Fee

For approved application requiring recording, applicant shall pay a handling/delivery fee payable to **Town of Rye** \$50.00

Inspection Fees:

Per S. 202-4.0 applicants will be required to pay the costs of construction inspection by the Planning Board Engineer after plans have been approved. A separate escrow agreement will be drawn to cover the construction inspection fees. Generally, this only involves major site developments and subdivisions.
