I. Call to Order and Pledge of Allegiance The Rye Sewer Commission Meeting was called to order at 8:15 a.m.

## II. Compliant Statement by David Kohlhase

# III. Roll Call

David Kohlhase, Lee Arthur in the room; David Adams, no one else in the room, and Lee Arthur, David Kohlhase in the room.

# IV. Announcements

There were no announcements.

Motion was made by David Kohlhase to take under Old Business, 2257 Ocean Boulevard, Map 5.3, Lot 7 out of order. Seconded by David Adams. All in favor roll call vote: David Kohlhase, yes; and David Adams, yes. Motion carried.

# V. Old Business

# 2257 Ocean Boulevard, Map 5.3, Lot 7

Included in the meeting packet was the Board of Adjustment Notice of Decision, the current property sewer tie, and updated sewer plans. Lee Arthur indicated that she inspected the sewer capping and a modular home will be constructed onsite. The builder attended the March 10, 2020 Sewer Commission Meeting and was provided a list of items that needed to be addressed including the sewer plans. Peter Kasnet has reviewed the plans and wanted to know the location of the cleanout; pointed out not to use a vertical 90 underground, use two 45 fittings; if pipe is less than 4 feet deep it must be insulated with at least 2 inch Styrofoam; and what does the 72" refer to on the plan.

The clean out location was discussed, and Drew Pierce indicated that it would be outside directly where the line exits the house within the first foot. He also mentioned that they would be using two 45 degree fittings and not a 90 degree. It was noted that the information/detail would need to be added to the sewer plan. The depth of the line is three feet and was not originally covered with Styrofoam. It was pointed out that Styrofoam is needed. The 72" on the plan referred to the invert for the site work contractor so he knows how far down the wall to place the pipe from top of foundation.

David Kohlhase indicated that there is sewer at the property, and it is a reconnection. It was noted that a building permit has not been issued. Lee Arthur asked that the Sewer Department be notified in advance in order to schedule the inspection. Drew Pierce noted that the sewer reconnection would possibly take place at the end of June.

Motion was made by David Kohlhase that the sewer reconnection at 2257 Ocean Boulevard be approved based on the condition that the sewer plans are updated (to show the location of the clean-out and two 45 degree fittings in place of a 90 degree fitting) and that all outstanding paperwork including the building permit is received. Seconded by David Adams. All in favor roll call vote: David Kohlhase, yes; and David Adams, yes. Motion carried

#### VI. O&M Report, June 9, 2020 Consideration of the O&M Report

The flow summary for Church Road Station in March, 3,074,400 gallons and the rainfall amount was 2.82 inches. The pump data graphs for Church Road Pump Station, Jenness Beach Pump Station and Abenaqui Pump Station for March were reviewed. On March 10, 2020 one of the pumps was down temporary. The flow summary for Church Road Station for March in 2019 was 3,217,800.

The flow summary for Church Road Station in April, 4,543,100 gallons and the rainfall amount was 4.43 inches. The pump data graphs for Church Road Pump Station, Jenness Beach Pump Station and Abenaqui Pump Station for April were reviewed. The flow summary for Church Road Station for April in 2019 was 3,135,000.

The flow summary for Church Road Station in May, 3,080,000 gallons and the rainfall amount was 1.62 inches. The pump data graphs for Church Road Pump Station, Jenness Beach Pump Station and Abenaqui Pump Station for May were reviewed. The flow summary for Church Road Station for May in 2019 was 3,254,800.

Lee Arthur reported that the sewer system was flushed in May and the wet wells have been cleaned. She indicated that Chris-Co. has been contacted regarding a schedule to repair the sewer line at Jenness Beach Station.

Motion was made by David Kohlhase to accept the O&M Report as read. Seconded by David Adams. All in favor roll call vote: David Kohlhase, yes; and David Adams, yes. Motion carried

# VII. Approval of Minutes

It was noted that current year's expenditures to the end of April were \$55,606.34 with 82.77 percent left. The Sewer Operational Account balance on April 8, 2020 was \$719,202.11. The Sewer Fund had a balance of \$581,483.76 on March 31, 2020. The Sewer Operational Account balance on May 9, 2020 was \$736,305.95. The Sewer Fund had a balance of \$581,676.82 on April 30, 2020.

Lee Arthur indicated that after the second quarter usage is received, she will be able to determine if the pandemic has affected revenue.

She was concerned about the status of the Route 1 Project and where it stood as they could be eligible for funds under this program. The Sewer Commissioners directed her to forward the information to Tim Phoenix and Bill Epperson.

# Other

Included in the meeting packet was an e-mail from Jeff Fort of 2310 Ocean Boulevard requesting that the outside meter display requirement be waived. He pointed out that he is a year-round resident and the interior meter can be read by himself or town representative.

Motion was made by David Kohlhase to waive the outside secondary meter reader requirements for 2310 Ocean Boulevard. Seconded by David Adams. All in favor roll call vote: David Kohlhase, yes; and David Adams, yes. Motion carried.
