ARTICLE 02. To hear and act upon any reports of agents, auditors or committees of officers heretofore chosen.

ARTICLE 03. To see if the District will allow and vote the same time payment dates and time limit(s) on all District property taxes as the town of Rye shall allow on its property taxes. (Majority vote required)

ARTICLE 04. To see if the District will vote to raise and appropriate \$92,645 to defray District charges for the ensuing year. This amount. (Article 04 is recommended by the Municipal Budget Committee, Majority vote required)

ARTICLE 05. To transact any further business that may legally come before said meeting.
