## **Request for Proposals for Turf Management and Mowing Program: The Town of Rye Recreation Area**

Sealed proposals for The Turf Management and Mowing Program for the Town of Rye Recreation Area at 55 Recreation Road, Rye, NH will be received at the office of the Selectmen, 10 Central Road, Rye, NH 03870 until 2:30 p.m. Wednesday, March 30, 2022.

- Contractor and their sub-contractor must be fully insured including workers compensation and provide a certificate of insurance indicating the Town of Rye as additional insured with their proposal.
- Contractor or sub-contractor must have a New Hampshire Pesticide Control License.
- The Town of Rye is seeking one contractor that is responsible for the overall management of both the Turf Management and Mowing Program and can sub-contract services.
- Contractors must fill out the schedule of values completely as requested and return it with their proposal to be considered responsive.

### ***Proposal Specifications for Turf Management:***

#### **RALPH MORANG MULTI-PURPOSE RECREATIONAL FIELD**

- The Ralph Morang Multi-Purpose Recreational Field includes one 330' x 185' Soccer Field, two 185' x 100' Soccer Fields and Baseball Field. Total area approximately 330' x 410'.
- Fertilization: Three individual granular applications of a "bridge" fertilizer (50% organic and 50% synthetic) providing at least  $\frac{3}{4}$  of a pound of nitrogen per application. To be applied once in the spring, once early summer and once in the fall.
- Weed Control: Two individual liquid applications of a broadleaf weed control containing 2, 4-D (Example: Lesco 3-Way). To be applied once in the spring and once in the fall. Two individual granular applications of Dimension crabgrass control. Both to be applied in the spring.
- Insect Control: One individual granular application of a product that contains .2 % Imidacloprid (Merit) for grub. To be applied in June. Two individual granular applications of a surface feeding insect control containing Bifenthrin. To be applied as needed.
- The Town of Rye reserves the right to adjust the products used and applications as needed.

### ***Proposal Specifications for Mowing:***

***NOTE: Grass clippings shall be disposed off-site.***

- Cut Multi-Purpose Recreational Field. Total area approximately 330' x 410'. That includes one 330' x 185' Soccer Field, two 185' x 100' Soccer Fields and Baseball Field, cut and bagged if necessary. April 22 - October 14, 2022 once a week (26 x).
- Thursday service preferred.
- Additional mowing maybe requested due to growth and field use needs.

#### **FLASH JENNESS MEMORIAL BASEBALL FIELD**

- Infield cut in two directions and bagged; outfield cut in two directions and bagged if necessary. April 18 - July 22, 2022 twice a week (28 x) and July 25 - October 14, 2022 once a week (12 x).
- Cut and trim the outside fence perimeter of field once a week, April 18 - October 14, 2022 (26 x).
- Monday and Thursday service preferred.
